Guidelines and Conditions for applying to the 19+ Learner Support Fund 2021/22

Deadline for completing application form is Friday 8 October 2021.

Applications received after this date will be considered but subject to available funds.

Funds are limited and targeted at those most in need. All requests for funding will be considered although it may not always be possible to help. If the funding is exhausted, the College reserves the right to close the fund.

Learner Support Fund

This Fund is a means-tested grant to assist students who have financial difficulties while studying at the College on a level 2 or below course. The fund can contribute towards the cost of your course including course fee, essential equipment, trips, travel costs and childcare costs.

Advanced Learner Loan Bursary

The Advance Learner Loan Bursary Fund is for students who have had a loan approved by the Student Loans Company, for level 3 courses. This fund can provide financial support to cover course related expenses like childcare costs, travel and kit/uniforms. Students with learning needs or disabilities can also receive support whilst on their course.

Student Eligibility

Students are eligible to apply for funding if they meet the following requirements:

- You must be aged 19 or over on 31 August 2021
- Meet the residency criteria
- Enrolled on an eligible course
- Household (annual gross) income of less than £25,000 (different income for help with course fees)

Supporting Documents

Students applying for the above funds must provide one of the following:

- Income Support (issued with the last 3 months)
- Universal Credit (3 most recent monthly award statements)
- Income-based Jobseekers Allowance (issued within the last 3 months)
- Income-related Employment and Support Allowance (issued within the last 3 months)
- Support under part 6 of the Immigration and Asylum Act 1999 (NASS Support)
- Guarantee element of State Pension Credit
- Child Tax Credit and have an annual gross income of no more than £25,000
- Copy of their 2020/21 P60 certificate
- HM Revenue & Customs Self Employment Tax Return

Young Adult Carer

A young adult carer is someone aged 16-25 who helps look after someone in their family with a disability, illness, mental health condition, or a drug or alcohol addiction.

Travel

Funding for travel is available to students who live three or more miles away from their College site. Payments are made half-termly and pro-rated if attendance drops below 100%. Travel costs based upon the cheapest mode of public transport (bus). Any travel discounts available to students will be deducted from their overall allocation. To see if you are entitled to any discounts please visit www.tfl.gov.uk/tickets.

Students applying for 18+ student oyster must meet the required minimum of 15 tuition-led hours a week.

Equipment Costs

Students purchasing essential uniform and equipment can receive a partial refund. Students must produce receipts to claim a refund. Payments will be made after October half term.

Award

The Student Finance team will assess the value of the award after receiving a completed application form with supporting evidence.

Attendance

Students must maintain a minimum attendance requirement of 90% to receive payments. Attendance deemed unsatisfactory will result in non-payment.

Bank details

Students must provide their bank account details. Failure to provide correct bank details will result in a delayed or non-payment. You should still submit your application form if you do not have a current bank account.

Appeals

Students have the right to appeal against any decision regarding their application please contact the Well-being and Support Team for further information.
