#### 59.18 APPOINTMENT OF A SENIOR POST HOLDER - DEPUTY PRINCIPAL QUALITY & CURRICULUM

Following a national recruitment campaign, which was led by AoC Create, members of the Selection Panel met on 29 June 2018 and reviewed the applications for the post of Deputy Principal Curriculum and Quality.

Five applicants were subsequently invited for interview on Thursday 19 July 2018.

A rigorous assessment day was held which comprised a number of activities involving some Governors, staff and students who all contributed their views to the Selection Panel for consideration.

The Chair provided feedback from the interviews including the candidates relative strengths associated with the remit of this post and areas where the panel had probed in depth to check their knowledge and experience.
