Waltham Forest College – subcontracting rationale

Waltham Forest College’s approach to subcontracting is to extend the accessibility of provision for learners which fits with the College’s strategic objectives enhancing the opportunities available and providing expert provision. The College subcontracts to extend the breadth of its provision, broadening the range of sector subject areas that can be covered, to provide training opportunities for a range of learners who may not be able to study at the main College. Subcontracting offers flexibility by delivering provision at times and venues convenient to learners and employers meeting demand from key stakeholders such as local employers or Jobcentre Plus.

All subcontractors have a contractual relationship with Waltham Forest College and are subject to a robust due diligence process. Subcontracts are only awarded where our due diligence determines that the subcontractor has the capacity to deliver provision to the expectations of Waltham Forest College and regulatory bodies including the ESFA, GLA and Ofsted.
